#### Editor's Notes and Ramble: Hi Shipmates!

I think the Grim Reaper took the Holidays off to sharpen his scythe or maybe he just misplaced it. Whatever the reason, it was great to enjoy the festivities without the merriment being broken by the notification of a shipmate passing. We even were able to finish out 2007 with a 'BANG' by taking two shipmates <u>off</u> the 'DECEASED' rolls.

Sorry 2008 couldn't be as promising but, as you read the following, you'll see that the Reaper didn't waste any time to get back to his intended duty and try out his newly sharpened scythe.

Bob Cellupica was a MotorMachinistMate who served aboard BANG from 44 to 46 including the last two War Patrols (5&6). He kept in close touch with his shipmates through the years and later on he was a good supporter of the Bang Gang. Until recently, he attended most Reunions and sometimes brought his brother and grandson along. About a year ago Bob was moved into a Nursing Home. Carl Weber informed me on 1/8 that Bob had passed away. He was a good shipmate and friend and he will be missed dearly.



Laconia-----Robert Victor Cellupica, 82, of 15 Elizabeth Terrace died at the St. Joseph Hospital, Nashua on Thursday, Jan. 3, 2008. He had been a resident of Forest View Manor, Meredith since April, 2007.

Mr. Cellupica was born November 4, 1925 to Francesco and Vincenza (Girardi) Cellupica in Gorham, (Cascade) N.H. He attended St. Benedict Parochial School in Cascade and

graduated from Gorham High School in 1942. He earned letters in football, basketball and baseball. Following graduation, he worked in Portland, Maine at the Todd-Bath and South Portland shipyards and also at the Brown Co. Tube Mill in Berlin, then worked at the Portsmouth Shipyard as a blueprint clerk and enlisted in the Navy in 1943 at age 17. He attended Boot Camp in Newport, Rhode Island and volunteered for Submarine duty. He served in the Pacific aboard USS Bang (SS385) and took part in successful patrols in the Yellow Sea and western Pacific participating in the Iwo Jima and Okinawa campaigns. On April 21, 1945, Bang rescued a downed flyer, **Don Corzine**, a graduate of Brown University, off the island of Ishigaki in 1945. His service medals include American Theater, Pacific Theater with two stars and the WWII Victory Medal. He qualified in submarines allowing him to wear the twin dolphins. He earned the Submarine Combat Insignia with one star.

Following discharge, he worked in the Brown Co. Woods Dept. as a clerk in lumber camps in East Bethel and on Lower Richardson Lake in Maine and Bog Brook camp in N.H. and on a log drive at Upper Dam between Lake Mooselookmeguntic and Richardson Lake in Maine.

He attended Burdett College and graduated in the Accounting-Business Administration course. He worked for Metropolitan Life Insurance Co. in Woodsville and Lancaster and was employed for more than thirty years as an Outside Plant Engineer with New England Telephone and retired from Verizon in 1986.

Mr. Cellupica served as a Selectman in Lancaster, moved to Laconia in 1959 and served two terms as Councilman in Laconia's Ward II. He was a former member and Junior Vice Commander of Ross-Wood Post American Legion Post #20 and a former member of the Lions Club in Woodsville and a former member of Mahaney-Brisson, American Legion and the VFW in Lancaster. He was a member of Wilkins-Smith American Legion Post #1 of Laconia. He was a past president of Lancaster Kiwanis Club, a 3<sup>rd</sup> Degree member of the Knights of Columbus since 1951 and was a Past Grand Knight. He served as secretary of the International Brotherhood of Telephone Workers and had been a member of the Elks since 1947 and was a life member of Laconia Lodge #876. He was a member of Squalus Chapter, Submarine Veterans of WWII. (Maine and New Hampshire.)

Survivors include, son, Robert Cellupica, and his wife, Ellen (Sevigny), of Hopkinton, MA; a daughter, Denise Cellupica-Bourgoine and her husband, Dustin, of Laconia; a son, Peter Cellupica, and his wife, Joan (Trainor), of Laconia; a son, Gerard Cellupica, and his wife, Elaine (Corriveau), of Colorado; six grandchildren; two step grandchildren; a brother, Anthony Cellupica, of Berlin; a sister, Mary Bosa, of Berlin; a brother, Francis, of Dover; and several nephews and nieces. He was predeceased by his wife, Laurette (Montminy) Cellupica in October, 1999.

Internment will take place in the Columbarium at the New Hampshire State Veterans Cemetery in Boscawen at the convenience of the family. **Raymond Bensen** was an original plankowner, commissioning BANG in 1943 and bringing her back to Portsmouth in 1945. He was aboard for all of BANG's patrols except #5. Word of his demise was passed on to us by the SubVets WWII organization and the following obituary is all that was posted in his hometown paper.

Since Robert was not an attendee of our Reunions, I know little about him other than he was a shipmate and, because of that, we all will miss him.



April 14, 1914-March 23, 2007 **Raymond Frank Bensen Sr.** 92, the last of four close brothers, died peacefully in Davis, his daughter at his side and family near by. He came with his wife to Davis in 1980, to live near his daughter and to help with her two young daughters when she was accepted to the School of Veterinary Medicine at UCDavis. He is survived by Delphine,

his wife of 59 years; daughter Billie **Bensen** Martin and her

husband Barry; granddaughters Sherri Cowden and husband Ron, and Amy Bisek and husband Don; greatgrandchildren Kevin and Ross Cowden and Bradley and Claire Bisek; step-granddaughter Ann Martin and husband Steve Olny; and stepgreatgrandchildren Tanner, Hunter, Garrett, and Wyatt Olny — all of Davis.

He is also survived by his son Jeffrey A. **Bensen** and his wife Lydia, and step-grandson Seph McCarty of Lompoc; and son Raymond F. **Bensen**, Jr. and his wife Nancy and granddaughter Meghan **Bensen** of Aptos; grandson Chris **Bensen**, his wife Tara, and greatgranddaughter Maya of Scotts Valley; and stepgrandson Robert Martin, his wife Lisa and stepgreatgrandchildren Josh and Madelyn of Sutter.

He joined the U.S. Navy during WWII and volunteered for submarine duty. He served on the U. S.S. Bang as a radio/radar technician, earning a Silver Star and two Bronze Stars during combat in the South Pacific. He was a member of U.S. Submarine Veterans WWII San Francisco Chapter, a member of the Bang Gang and life member of Veterans of Foreign Wars, Aptos Post 10110.

After the Navy, Ray worked as an electronics engineer for Lockheed Missiles and Space Company, beginning in Van Nuys in the 1950s; Santa Cruz Test Base; Sunnyvale; and Vandenberg Air Force Base in Lompoc. In 1978 he retired to pursue his favorite pastime, the game of golf.

Ray was an avid golfer, appreciating sanctuary on the "green grass" at Davis Municipal Golf Course. He

played nine holes of golf on his 90th birthday, but by far his greatest joy was spending time with his family. He often commented, "These are the best years of my life."

A memorial service was held Saturday, March 31, at Wiscombe's Davis Funeral Chapel, 116 D St. in Davis. In lieu of flowers, contributions may be made to the Davis Junior Golf Program, c/o Jerald Lilliedoll, P.O. Box 928, Davis, CA 95617.

**Subject: Military Retiree Account Statement** Just wanted to let you know that the same as many of you I recently received my Military Retiree Account Statement.

Please review the back of your statement and verify who you have designated as the beneficiary in case you die.

Mine has changed to someone I don't even know (Cathy J. McMillin "wife") as getting 100%. Based upon the fact that recently the VA had their military retiree personnel information compromised it is interesting that somehow my beneficiaries have changed.

If you look at the broader picture of what this means is that many veterans probably wouldn't catch this and as we lose more of our fellow service men and women each day this would leave their dependents without the benefit they deserve.

I called 1-800-321-1080 on 1/15/2008 and they will send me another beneficiary form to fill out within 7 business days. When I read her my e-mail she just blew it off.

Please send this out to the retirees you know and alert them to check who their current beneficiary is. Ask them to pass it along.

#### AO Bulletin Update 1 January 2008

**AID & ATTENDANCE UPDATE 02**: This Special Pension (part of the VA Improved Pension program) allows for Veterans and surviving spouses who require the regular attendance of another person to assist in eating, bathing, dressing, undressing or taking care of the needs of nature to receive additional monetary benefits. It also includes individuals who are blind or a patient in a nursing home because of mental or physical incapacity. Assisted care in an assisted living facility also qualifies.

This most important benefit is overlooked by many families with Veterans or surviving spouses who need additional monies to help care for ailing parents or loved ones. This is a "pension benefit" and is not dependent upon service-related injuries for compensation. Most Veterans who are in need of assistance qualify for this pension. Aid and Attendance can help pay for care in the home, nursing home or assisted living facility. A Veteran is eligible for up to \$1,519 per month, while a surviving spouse is eligible for up to \$976 per month. A couple is eligible for up to \$1,801 per month. To be eligible the veteran must have served during one of the following periods:

• World War II: December 7, 1941 through December 31, 1946

• Korean War: June 27, 1950 through January 31, 1955

• Vietnam War: August 5, 1964 (February 28, 1961, for veterans who served "in country" before August 5, 1964), through May 7, 1975

• Gulf War: August 2, 1990, through a date to be set by law of Presidential Proclamation

The VA must determine that your net worth is such that it will probably not support you through the remainder of your life. The VA does not include primary residence or vehicles when determining net To qualify you must have a "countable worth. income" of less than the pension amount to be eligible for all or a portion of the pension. Countable Income is the amount of income a veteran or surviving spouse receives each year, AFTER deducting all unreimbursed, recurring health care expenses. This includes assisted living costs, home health care, insurance & Medicare premiums, ongoing pharmacy costs and more. If you have dependents, their health care costs can also be used to reduce your countable income. However, their income must also be added into the equation. There are three levels to the Improved Pension program: Basic Pension, Housebound, or Aid & Attendance. Each tier has its own level of benefits and qualifications. If you or your loved one does not qualify for Aid and Attendance, you may want to check to see if you qualify for another level of the

Pension. For example the following would apply for eligibility to receive the Basic Pension:

• A veteran earns \$14,000 per year from Social Security. His wife earns \$9,000 per year. The veteran also earns \$5,000 per year from a small company pension giving the couple a total annual income of \$28,000.

• The couple has \$38,000 in net worth in CDs and savings and they still live in the home they bought in 1954. This is not enough to support them for the rest of their lives...

• The veteran pays \$1,800 per month for his wife's home health care, they each pay a monthly Medicare premium of \$93.50 (x 2 = \$187/mo), and he also pays \$149 per month for supplemental insurance. Thus, their total medical monthly expenses are \$25,632 per animus.

• When you subtract the medical expenses from their total income, you get a "countable income" of only \$2,368. The maximum benefit amount of \$14,313 minus the countable income amount of \$2,368 equals \$11,945 which would be paid by the VA if the veteran applies for it...
